# **IDP Project Update**

The Summer Village of Larkspur and Westlock County have engaged Municipal Planning Services (MPS) to assist with the preparation of an **Intermunicipal Development Plan (IDP)**.

An IDP is a high-level statutory land use plan for areas of mutual interest of two or more neighbouring municipalities that share common boundaries.

Throughout 2020, the Summer Village, the County, and MPS have been working to prepare a draft IDP. A newsletter was sent to community members in February 2020, which included an online survey. Responses to the survey were shared with both municipalities and used by MPS to develop proposed policies in the IDP.

## June 14 - Online Public Engagement

Typically, public engagement for a project like this would include an open house where the project team could meet community members and discuss the details of the proposed new IDP. However, to ensure the well-being of the community and to comply with provincial COVID-19 requirements, the public engagement will be held online.

The online public engagement session is an opportunity for residents to learn about the draft IDP, ask questions, and provide feedback.
