LEGAL DESCRIPTION OF PROPERTY: _____

The permit holder must be a resident of Westlock County to apply for a permit to use the Westlock County Transfer Stations and/or the Westlock Regional Landfill. For residential waste only, NOT for commercial waste.

The permit holder must show the permit to the scale operator to gain admittance to the transfer station or landfill. In the case of a lost permit, the original permit will be canceled, and a new permit issued to prevent usage of the lost permit.

The permit holder and/or his/her authorized agent hereby agrees to abide by the policies and procedures of Westlock County and the Westlock Regional Waste Management Commission (WRWMC) and any revision that may be made by the County or Commission from time to time.

The permit holder and/or his/her authorized agent will be subject to load audits and waste screening at the waste management sites and hereby further agrees that any waste delivered to and deposited at the waste management site is acceptable under Alberta Environment Protection and Enhancement Act, Waste Control Regulation, and any other governing regulation for a Class II Municipal Landfill Site.

The permit holder and/or his/her authorized agent hereby indemnify and save completely harmless (Westlock County, the Westlock Regional Waste Management Commission, and staff) against all actions, proceedings, claims, fines, demands, losses, debts, costs, damages, and expenses which may be brought forth.

The permit holder and/or his/her authorized agent must at all times abide by the Highway Traffic Act and any other regulation governing the equipment and operators thereof, including any related to Westlock County or the Westlock Regional Waste Management Commission's policies while on site.

The validity of this agreement and the legalities of the parties shall be governed by the laws of the Province of Alberta.

Westlock County and the Westlock Regional Waste Management Commission hereby reserves the right to make changes to its policies and forms, including this application, from time to time without prior notice.

The completion of this form does not in any way directly authorize the shipment of wastes to the waste management sites; the County and Commission reserves the exclusive right to withdraw any and all rights given under this agreement at any time without prior notice.

This permit is only valid for this calendar year for up to an annual tonnage of 4000kg. Permit holders who exceed this limit will be invoiced by Westlock County the current tippage fee as established by the WRWMC plus a 5% administration fee.

This permit may be canceled at any time at the discretion of the issuer.
